### Chief Report –Don Vadakan

FD gave \$10,000.00 donation to buy 4 digital radios. Squad has to spend \$1500 from our budget. Radios will soon be ordered.

Don met with Mr. Bob Mency, a lawyer and chatted about the sexual harassment policies. Bob says this is not covered under workers compensation. Bon offered to meet on Thursday to have a initial discussion. Any legal advice offered will be brought to eboard. Suhas

supported the idea of taking a proper legal advice. Don and Arun will meet the lawyer at his office. He can be engaged if needed, based on his advice and eboard approval further actions will be discussed. Suhas confirmed Funds were kept aside for if needed.

There was a Claim by one of the ex-cadets about sexual harassment while on duty in the premises of the squad. There were no damages. Cadet claims that when she complained, the leadership didn't give much attention and was shut down which caused trauma. When approached, Liability insurance company rejected saying the incident happened on premises and advised to approach workers compensation claim. Township sent the claim and was rejected.

Lawyers advised, if Some one is inured, then Claim by the officials of the organization to traumatic incident need to filed against workers com. If rejected contact for legal advice.

Arun will share the available documents to Don to follow up with the lawyer.

Discussion at PD director level, sources mentioned that Petems will be rolled into FD. Nothing on papers yet and it won't be coming into existence until next year Timing may change. Squad agreement with Township also may get affected, funds may go down.

Arun suggests FD can rent our ambulances and can talk about funds distribution.

Deputy mayor suggests if PRS is struggling to raise money, merge with FD and budget can be managed.

Mayor Cantu suggested to form a committee and discuss the possibilities.

Arun adds – PRS funds put in investments – will be put in danger with the cases like these.

Counter suit can be filed based on our profile. All the activity has to be documented for future.

Election process need to be streamlined and documented.

#### Trustees - Anil Raavi
